Course Description

The *PPP Project Management and Implementation* course, developed by the Institute for Public-Private Partnerships, A Tetra Tech Company (IP3), will teach participants how to plan and prepare for managing and monitoring public-private partnership (PPP) contracts after they are signed. Participants will also be able to prepare contract management plans and develop and manage procedures for monitoring and reviewing PPP project performance.

This course will address the implementation issues that may be encountered in PPPs. The discussion will focus on the role of the project implementation unit, the development and execution of a project implementation plan, the tracking and updating of the project risk profile, and the ongoing validation of value for money (VfM) parameters.

- Design a detailed, strategic PPP action plan to apply learning outcomes on the job

Establishing Effective Monitoring and Evaluation Systems — Evaluating M&E Systems

- Examining institutional structures, roles and responsibilities for PPP project M&E
- Review of key M&E system steps: translating project goals into M&E scope, defining parameters for data collection, setting targets and utilization of data
- Discussion of data demand (internal and external)
- Reviewing and adapting M&E checklist to participants' unique circumstances
- Improving M&E in government

Performance Standards and KPIs for PPPs

- Examination of PPP KPIs in different sectors
- Difficulty of choosing the right KPI
- Role of KPI in PPP contracts and enforcement issues

Stakeholder Communication and Evaluation

- Stakeholder analysis and preparation of stakeholder register, community profiles, and engagement tracking
- Effective messaging using framing, resonance with stakeholder ideals, and powerful words and images
- Introduction to new media tools for outreach and communication
